Justice of the Peace Rohrback of Pajaro Insults the Filipinos

With a Chain of False Statements Succeeds in Making the Northern Monterey County Chamber of Commerce to Pass a Resolution Against Them

Just a few days after the "Good-Will-Trip" arrived in San Francisco from the Orient where Americans found a very hearty welcome; and not very far from the closing date of the Pan-Pacific conference in Japan where American delegates promised to work toward better understanding between Americans and Orientals whose friendly relations have been doomed lately by news sent across the Pacific from the East, saying that "racial-prejudice" is getting intolerable in this country, now comes the Justice of the Peace of Pajaro, California, insinuating violence against Filipinos.

Somewhere in this pamphlet you will read that Justice D. W. Rohrback is said "to have made a comprehensive study" of the whole subject. I wonder what slander could he say worse than what he said if he did not make the "study."

I would like to know who was the internal revenue officer who "dreamed" that there were boats arriving in the coast with thousands of Filipinos. I appeal to the U.S. Customs of the State of California who has a complete record of the number of Filipinos arriving in each steamer from Hawaii and the Islands and there was never a boat with more than 500 Filipinos, many with none.

The Filipinos by Constitutional rights can come to this country freely as Americans are guaranteed freedom to go and stay in the Philippines.

If Rohrback is really a good Justice of the Peace, he should advocate a peaceful settlement of the case;

FILIPINO BAN URGED BY CHAMBER OF COMMERCE AT PAJARO CALIFORNIA

(Salinas Index-Journal, Jan. 11, 1930)

Northern Monterey county chamber of commerce is opposed to Filipino immigration, and even to the Filipinos who are already here, and its members are not only talking about their opposition, but are taking action to curb the immigration of the "little brown brothers."

At a meeting held in Pajaro, Wednesday night, the chamber passed a resolution charging the Filipino population of this district as undesirable and of possessing unhealthy habits and being destructive to the living wage scale of other nationalities in agricultural and industrial pursuits. Copies of the resolution are to be sent to the Monterey county board of supervisors, Governor C. C. Young and Senator Hiram Johnson, at Washington, D. C.

The resolution is said to have been drawn up by Justice of the Peace D. W. Rohrback, of Pajaro, who is said to have made a comprehensive study of the effect of the presence of the Filipinos in this district and in other parts of the state. Rohrback is reported to have said that this move on the part of the northern Monterey county chamber of commerce was but the beginning of an investigation of a situation "that will event-

he should advocate the granting of Philippine Independence in exchange for the "shipping-back home" of all religions in this country, if he so desires. (A thing we Filipinos will greatly appreciate.) He does not need to insult us because we can sure answer him back that if we are "deteriorating the white race" what about the Americans in the Phillipines? Phillippines?

Did he find out in his "study" that most prostitutes in the Phillippines now are abandoned daughters of American soldiers? Did he read the appeal made by the late Governor General Wood to the Americans regarding their countrymen's children left helpless in the Philippines? Can there be a greater "deterioration" than this pathetic picture?

Rohrback also says that we are "but 10 years removed from a bolo and a breechclout," we are proud of it, Mister. What is the use of a "high-hat" and a "full-dress"?

Read our criminal records in the Philippines and also read many speeches delivered by your own representatives and senators recorded in the files of Washington, where Filipinos were called law-abiding

people.

And now read Brisbane who says in the San Francisco Examiner, the following: "There was never a nation, half civilized, with such disregard for law, such a frightful and growing wave of crime as may be found in this country."

Would you not feel proud to have "emerged" from "bolo and breech-clout," and after ten years be a re-

spectful citizen?

It is really too bad that I had to answer Rohrback, "using for him his own medicine."

Let us go further:
"Fifteen Filipinos will live in a room or two," he says. What about it? Forced by the circumstances, "super-complexed-people" sleep the same way in the slums of Chicago, New York and worse in London, where many rooms lack light and baths.

Why don't this Rohrback begin the "cleaning" among those of his

own "color"?

And if the Filipino housing conditions are bad in his own opinion, why not endorse the case to the State's Building Inspector? Un-healthy? Ring the Health Officer of the State. Don't sit and cry like

If Rohrback made a conscientious study of unemployment in this country he should have found out that the main causes of it are the following: Machinery which is turn-ing out of work the greatest number of laborers; women, who quit housework and are replacing men in many factory and office jobs; systematiza-tion and simplification of work, and

employment of children

There are about 75,000 Filipinos in the whole United States and about 45,000 to 50,000 are in California during winter as many go to the middle states in summer. If Filipinos are taking the white mens' job the white-men unemployed must ap proximately correspond to the number of Filipinos, and not come to mil-

lions as is the case at present.

Most Filipinos work in the lettuce fields. The lettuce is a new product in the Salinas Valley. No white-men thinned lettuce before the Filipinos. Work in the lettuce fields is very hard. Why "kick" if Filipinos want to share in some easy work?

Filipinos can never be treated as slaves. If Rohrback wants to see the Filipinos out of the City, "jailed" in the field and camp, not "mixing" with white people he will heave to with white people, he will have to go to the grave without seeing it. From the primary school in the Islands we begin to get familiar with Lincoln.

"As Filipinos eat cheap food, they will soon be well clothed, and strutting about like a peacock, they en-deavor to attract the eyes of the young American and Mexican girls"

Rohrback says.

That is the law of Nature, the male must do his utmost to attract the attention of the female and vice-

We Filipinos were brought up under the Christian principle that God created men equal, and so we do not believe in "racial-superiority." We welcome Americans and other nationalities in our family circles, and Americans, more than any other foreigners in the Philippines take more Filipino women to the altar. We feel that as human beings we have the same inalineable rights in this country to take those who love us as our legitimate wife.

To discuss the Filipino diet is

stupid. Each nation has a particular diet and it is unreasonable to measure the standard of living of its people by what they eat or drink.

Now I will let Senator Burton K Wheeler of Montana give his own opinion about standards of living. The Senator says: "We Americans immediately attempt to judge the Filipino people according to American standards. We say, 'You do not live in accordance with our particular tendent of living and the accordance with our particular tendent of living and the say." standard of living, and therefore we think that you are not capable of self-government.' In other words, we set ourselves up as examples, and we say that our standard of living is the only correct standard of living; our religion is the only kind of religion that should be adopted in the world;

our methods and manners of living are the only kind to be followed.
'You ought to eat the kind of food
we eat; you ought to dress the same
way we dress'; and of course if we judge the Filipinos according to American standards, if we judge the Japanese according to American standards, if we judge the Russian people or the Italians, or a great many other people throughout the world by the American standard, then we would say that, according to our standard, they were not capable of self-government." (U. S. Senate, October 9, 1920).

October 9, 1929). What is bad if "the Filipinos form partnership and buy good cars and roll along the highways like Solomon in all his glory"? As an American, Rohrback should be glad that the Filipinos, instead of sending their honest-earned money to the Islands they spend in cars, tires, gas and repairs, leaving therefore the DOLLARS where they found it. And by the way was Rohrback ever approached by a Filipino begging for a nickle to get a cup of coffee? If Filipinos can afford to buy a car without bothering anybody why be fussy about it?

If not because I am positive that Rohrback is a very busy man, I was going to include him in Calvin Coo-lidge's classification, of men called "fringe of idle, vicious, boisterous wastrels." Men who devote their useful time in useless things.

I do not believe that Rohrback thinks that because there are more

Filipino men than women in this country, we are a moral menace here. If he believes that that is the case, he must also admit being under the same circumstances, that the Americans in the Islands are a menace too. In the Philippines American men

outnumber American women greatly.

Rohrback said that there were 75,000 Filipinos in a convention in Los An-

geles the other day.

Let us be honest in bringing figures. I am sure that nobody can prove that there was such a big gathering of Filipinos in Los Angeles neither in any place in this country. It is impossible to gather such great num-bers of Filipinos, and only in the mind of an "alarmist" such fancy could be created.

"We do not advocate violence," said the Judge. ually lead to the exclusion of the Filipino or the deterioration of the white race in the state of California."

Rohrback is alleged to have said that he has been informed by the collector of internal revenue that where boats used to land on the coast with a hundred or so Filipinos, whole boatloads now are landed with thou-ands of them, "but 10 years removed from a bolo and a breechclout."

Every time a boatload of Filipinos arrives, that many white men and women are thrown out of work, because they cannot work for the wages that the Filipinos get, according to the judge. He is reported to have said that "for a wage that a white man cannot exist on, the Filipinos will take the job and, through the clannish, low standard mode of housing and feeding practiced among ing and feeding, practiced among them, will soon be well clothed, and strutting about like a peacock and endeavoring to attract the eyes of the young American and Mexican

"Fifteen Filipinos will live in a room or two, sleeping on the floor and contenting themselves with squatting on the floors and eating fish and rice. The same group will form a club and buy a partnership in a classy automobile and attired like Solomon in all his glory, will roll along the highways."
